## Babe Ink Academy Oklahoma Approved Medical Micropigmentation Course



TRAIN WITH BABE INK A Career in Permanent Makeup

Permanent makeup is a very exciting and rewarding career. With a career in permanent makeup, you can be your own boss! With a Medical Micropigmentation License, the possibilities for growth are endless. You are not only limited to brows, eyeliner and lips. After mastering the standard procedures, many artists choose to advance into more advanced procedures through continuing education. These advanced procedures such as areola pigmentation, and scar camouflaging, are referred to as Paramedical Tattooing.

### How Long is the Course?

Our Oklahoma approved Medical Micropigmentation course is 300 hours. This course will be approximately 12-14 weeks long. Classes will be held 2 set days per week, during the day. Most of our courses will be held on Mondays & Wednesdays. During this course you will learn the fundamentals of Cosmetic Tattooing.

#### What Techniques Will You Learn During This Course?

The procedures you will learn during this course are Ombre Brows (also referred to as microshading or powder brows), Lip Blushing, and Upper Eyelash Enhancement Eyeliner.

Becca does not feel Microblading is a proper procedure because it is traumatic to the skin resulting in scarring. Most clients are not good candidates for this procedure. We will not train students how to microblade and will cover in detail the reasons behind this.

If a student wishes to offer Microblading (against our advice) after graduating and testing, you will be licensed to do so. We suggest you take a continuing education class to learn the technique of microblading before offering it to clients.

You will be required to perform up to 18 procedures a combination of brows, lips, and lash enhancement eyeliner to graduate the course. Students are responsible for finding their own models for these procedures. The models will pay a model fee of \$150 to Babe Ink to cover the procedure overhead/supplies used for their treatment including their aftercare kit. If their touchup is being done during training, the model fee for touchup is \$100.

#### **Oklahoma State Requirements**

To work as a Permanent Makeup Artist in Oklahoma, you are required to meet the following criteria. Must be 21 years of age

Must have a high school diploma or GED

No felonies or misdemeanors involving crimes of moral turpitude

You will be required to submit an affidavit of lawful presence with your OSDH application / US Citizen

You will be required to have an overseeing physician to work as a permanent makeup artist/medical micropigmentologist in the state of Oklahoma. This physician needs to be an MD, DO, or DDS. The laws for physician oversight vary based on which type of doctor you choose. These are rules/responsibilities are decided by the physicians governing board. You are responsible for finding your own overseeing physician, we can not assist with this.

Blood borne pathogen certification & CPR certification are required. These can be done online and must be completed by the end of the first week of class.

The state will require proof of the above listed requirements to be sent in with your application upon completion of the course. They will also run a background check.

#### Are There Any Other Requirements?

Becoming a permanent makeup artist may not be the appropriate career choice for you if you have neck, hand or back pain, issues with vision, or an unsteady hand. This career requires dedication, patience, the ability to remain calm under pressure, being able to be sedentary during procedures, and a natural artistic eye. You will be taught the fundamentals you need to succeed; However, it will be up to you to apply them. You will need to market yourself, build your business, practice, and grow as an artist. Beginning your career as a permanent makeup artist may be more challenging to those that are not already in the beauty or aesthetic industry than those who already have a client base. However, this is not a requirement. There are so many successful artists who began without any industry experience or client base. You are required by Oklahoma law to work inside a physician's office, and you are responsible for finding a MD, DO or DDS to work under. You will not be allowed to work until you have this. We understand that many pursuing a career in permanent cosmetics are already licensed in a field they may view as similar (examples: Cosmetologists, Nurses, Hygienists, etc.).

However, Medical Micropigmentation is a separate license, it is under the Oklahoma State Department of Health. You are required to take the full program as required by the health department, our overseeing board. because medical micropigmentation is its own license, you are not required to have any additional licenses to become a permanent makeup artist in the state of Oklahoma.

#### Where are the Classes Held?

Classes are held at Babe Ink which is located inside the Institute for Beauty, Wellness & Regenerative Medicine.

We are in Midtown Tulsa, on 19th and Harvard.

#### How Many Students will be in the Class?

We keep the class size small, with a maximum of 4 students per course.

#### What Is the Cost of This Course?

#### Enrollment Fee: \$3,000

The enrollment fee can be paid in person, by mail, or online by credit or debit card. The enrollment fee is non refundable and non transferrable. The remaining tuition balance due 2 weeks before the 1st day of class in the form of a cashiers check.

#### Option 1: The total cost of the course with your student kit is \$14,500.00

The remaining balance for option 1 due 2 weeks before the 1st day of class is \$11,500 Your student kit will include your machine & power supply, an eyebrow pigment set, a lip pigment set, eyeliner pigment, modifiers, secondary numbing, 40 cartridges, mapping essentials, a case, latex for practice, textbooks and so much more!

Option 2: If you do not wish to have the full kit, the total cost for our course is \$13,500.00 The remaining balance for option 2 due 2 weeks before the 1st day of class is \$10,500 This option will only include your textbooks, latex for practice, and machine & power supply. A student kit will not be provided.

#### **Financing Options**

Please reach out to your financial institution to see what options they have for you. If you are currently operating a successful beauty business, you may also want to check with the platforms you are currently using to see if your business is eligible for a loan. Often times, platforms such as Square and QuickBooks will have business loan options available to their clients. There are also private student loans available through companies like Earnest or SoFi.

We do not offer financing or payment plans at this time.

#### Are There Any Other Fees Not Included in The Tuition?

♥ CPR Certification \$12-\$15 online

♥ Bloodborne Pathogen Certification \$10-\$25 online

♥ OSDH Medical Micropigmentation Application Fee & background check approximately \$515.00

This fee will be due after completing your course.

You will submit it with your paperwork to the Oklahoma State Department of Health.

 $\blacklozenge$  State Testing Fee approximately \$200.00 -This test will be taken and paid for at a vocational school.

This will typically be several weeks after completion of the course. You may schedule your test after you have been approved by the OSDH to test.

 $\blacklozenge$  The model fees will be charged to the models prior to their service. The cost is not charged to the student. The model fee covers the procedure supplies and overhead used during their treatment.
